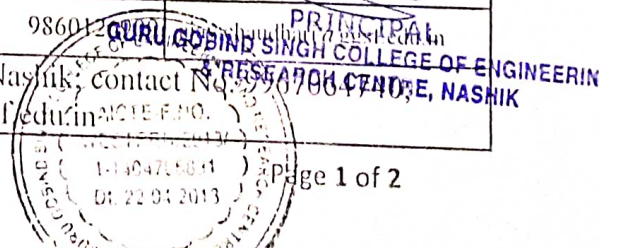
Office Order

Roles and Responsibilities of Anti Ragging Committee

- To ensure compliance with the provision of UGC regulation 2009 at the institute level.
- To monitor and oversee the performance of anti-ragging squad in prevention of ragging in the institution.
- The committee composed as above shall meet at least twice in a year to recommend preventive measures that can be adopted by the institute to prohibit, prevent and eliminate the menace of ragging in any form on campus of the Institute.

Role & Responsibility of the Anti-Ragging Squad:

- The Anti-Ragging Squad shall make surprise raids on hostels, and other places vulnerable to incidents and having the potential for ragging and shall be empowered to inspect such places.
- It shall also be the duty of the Anti-Ragging Squad to conduct an on-the-spot enquiry into any incidents of ragging referred to it by the Head of the institution, by any staff, any student, any parent, any employee of a service provider and any other person, as the case may be.
- The report along with observations shall be submitted to the Anti-Ragging Committee for action.
- The Anti-Ragging Squad shall conduct enquiry of incidence of ragging noticed by them during surprise raid, thoroughly observing a fair and transparent procedure & the principles of natural justice and after giving adequate opportunity to the student or students accused of ragging and other witnesses.

The tenure of nominated members will be renewed/ reviewed annually.
