IPC Sec 354 A

A man committing any of the following acts-- physical contact and advances involving unwelcome and explicit sexual overtures; or a demand or ...

A man committing any of the following acts--
physical contact and advances involving unwelcome and explicit sexual overtures, or
a demand or request for sexual favours; or
showing pornography against the will of a woman; or
making sexually coloured remarks, shall be guilty of the offence of sexual harassment.

Any man who commits the offence specified in clause (i) or clause (ii) or clause (iii) of sub-section (1) shall be punished with rigorous imprisonment for a term which may extend to three years, or with fine, or with both.

Any man who commits the offence specified in clause (iv) of sub-section (1) shall be punished with imprisonment of either description for a term which may extend to one year, or with fine, or with both.

Domestic Voilence Act 2005

- The Protection of Women from Domestic Violence Act 2005 is an Act of the Parliament of India enacted to protect women from domestic violence. It was brought into force by the Indian government and Ministry of Women and Child Development on 26 October 2006.

Pursuant to Chapter III of the Act, the aggrieved person has the right to:

- Apply for a protection order, an order for monetary relief, a custody order, a residence order and/or a compensation order
- Free legal services under the Legal Services Authorities Act, 1987
- File a complaint under section 498A of the Indian Penal Code.
